Superior Stucco Crack-Guard Mesh is an alkali resistant, woven glass fiber fabrics specially designed to be used with Superior Stucco base coats. Meshes are available in a range of weights that provide different levels of strength and impact resistance.

NOTE: DO NOT use CG-Mesh in EIF Systems. Use only EIF Reinforcing Mesh in EIF Systems.

Basic Uses

Superior Stucco CG-Mesh is designed to reduce surface cracking as part of the Superior Stucco Crack-Guard System, for adding impact resistance over architectural foam shapes, or for adding strength when used with approved Superior Stucco base coats.

The following Superior Stucco Meshes are available:

CG-Mesh Standard Roll (4.5oz / 38-inch roll): Superior Stucco CG (Crack-Guard) mesh is designed for use in the Superior Stucco Crack-Guard System and architectural foam shapes.

CG-Mesh Starter Roll (4.5oz / 9.5-inch roll): For back wrapping and detail work.

- 2. All Superior Stucco base coats

Application Instructions



Surface Preparation

All surfaces to receive application must be properly cured, clean and free of debris, dirt, dust, efflorescence, grease, oils, curing agents, and cleaning solutions. Ensure that all surfaces are smooth and free of any irregularities. Repair all cracks with the appropriate patching material for the existing substrate. It may be necessary just prior to application to dampen all surfaces that are to receive the Crack-Guard Base with clean, potable water.

Application

- 1. Apply a coat of the desired Superior Stucco base coat according to the appropriate Product Data Sheet's application procedures.
- 2. Embed the Reinforcing Mesh into the wet base coat using a steel trowel, troweling from the center of the mesh to the edges. Avoid Wrinkles in the mesh.
- Ensure that no Reinforcing Mesh is visible. Add base coat where needed.

Limitations

DO NOT deviate from the application procedures contained in this, or any other Superior Stucco Product Data Sheets, without written approval from San Jose Stucco Supply.

DO NOT allow any mesh to come in contact with petroleum products of any kind.

DO NOT allow mesh to show through base coat. Correct as necessary.

NOTE: Failure to follow manufacturer's written specifications could result in the following, but not limited to spalling, cracking, peeling, chipping, delamination, discoloration, wash off, and overall system failure.

Safety

Avoid contact with eyes or prolonged contact with skin. Wash thoroughly after handling. In case of eye contact, flush immediately with running water for at least 15 minutes. Consult a physician immediately. Do not take internally. Be sure to provide adequate ventilation in enclosed areas. Use of an approved respirator is recommended.
